#### Identification:

Waste fittings shall be marked with:

- a) The manufacturer's recognized name, trademark, or other mark; or
- b) In the case of private labeling, the name, trademark, or other mark of the customer for whom the fitting was manufactured.

Markings shall be accomplished by use of a permanent mark or by placing a permanent label on the product. Markings shall be located in such a way that they are visible after installation.

Packaging shall be marked with:



- a) The manufacturer's recognized name, trademark, or other mark; or
- b) In the case of private labeling, the name, trademark, or other mark of the customer for whom the fitting was manufactured.
- c) The ICC-ES PMG listing mark.

#### Installation:

The waste fittings shall be installed in accordance with the manufacturer's instructions and the applicable code.

Installation instructions shall be provided for elastomeric waste fittings and shall describe the methods for properly aligning the fittings.
